H. INFORMATION

Presentation of 2024–2025 Audit Report

Aaron Hunter introduced Ken Kuhns, auditor with Kenneth Kuhns & Company. Ken noted that, for years, the college has received the Government Finance Officers Association (GFOA) Certificate of Achievement for Excellence in Financial Reporting and has submitted its records again this year for review. Ken K. said the information in the report is based on the college's records. College staff have the responsibility to maintain clean, accurate financial records upon which the financial statements are based. The records were very well maintained and there were no audit adjustments or corrections that were required. There are three reports within the document addressing the audits.

First, Ken K. referred to pages 11–14 of the audit report – the Independent Auditor's Report. Ken K. referred to and read the opinion statement based on the audit and the report of the Foundation auditors, which conveyed the following: The financial statements were presented fairly and in all material respects; this was a clean opinion which is the best opinion that any entity can earn, and it was earned by Chemeketa through the financial statements that were presented for the audit for the year ending June 30, 2025.

The second opinion, on pages 120–121, deals with federal government auditing standards and the requirements regarding what needs to be reported. The internal controls on an entity-wide basis were reviewed to determine if the controls and procedures were sufficient to allow the college to prepare its financial statements accurately. No material weaknesses were found in the entity-wide controls on the college's financial statements.

The third part of the audit, on pages 124–125, determines whether the college has complied with certain statewide financial rules (e.g., local budget law, insuring money in banks, approved investments, public contracts and purchasing requirements, legal debt limits, etc.). The report indicates that the college has complied with the various state laws and regulations.

Diane Watson thanked Ken for doing a thorough job, and thanked the Finance Department for the good job they do year after year. Ken thanked the staff and board. Aaron noted the audit takes a considerable time, and commended staff in Business Services and Ken for the job they do.

Proposed Student Tuition for 2026–2027

Aaron Hunter referred to the green sheet reflecting the Proposed Student Tuition for 2026–2027 and provided an overview. He reviewed the items on the tuition and fee setting guidelines and discussed the fee increases:

- Tuition increase of \$3 per credit hour
- Universal Fee increase of \$1 per credit hour
- Out-of-State & International Tuition increase of \$3 per credit hour
- Differential fee remains the same

The proposed tuition increase would place Chemeketa fifth among comparator colleges based on current year rates. There are also proposed increases to the Bachelor of Applied Science in Leadership and Management tuition and fees, and the proposed Bachelor of Science in Nursing initial fees were discussed.

A student tuition forum will be held on January 27th to share the tuition proposal and answer questions. A recommendation will be brought back to the board next month for action. Aaron thanked Lillian Anderson for her assistance in setting up the forum. These proposals will be brought to the board for approval at its February meeting.

Proposed Budget Calendar for 2026–2027

Aaron Hunter reviewed the proposed budget calendar and discussed budget dates. The calendar will be brought back next month for approval.

2024–2025 Financial Aid and Veterans Services Update

Ryan West, Executive Dean, Student Affairs, discussed the financial aid application numbers, noting that this is the last year the college will have a 0.00% cohort default rate due to the return of student loan repayment, and next year there will be changes to this report due to major financial aid changes. Ryan thanked Angela Archer and the Veterans Resource Center team for the work they did to receive the Campus Veteran Resource Center Grant.

Advisory Committees for 2025–2026

Francisco Saldivar, Executive Dean, Career and Technical Education, noted that there was a small decline in the number of advisory members last year due to two programs being sunsetted. The list has been reviewed to make sure that it is up to date, and the committees meet three times a year. Francisco stated that there will be an all-advisory meeting in March.

Suspension of Pharmacy Management Associate of Applied Science Degree

Sandi Kellogg, Dean, Health Sciences, said there was not much student interest in the program, so the college decided to suspend it and will bring this forward for approval at the next board meeting.

Suspension of Pharmacy Technician Certificate of Completion and New Pharmacy Technician Certificate of Completion

Sandi Kellogg said this certificate is tied into the Pharmacy Management Associate of Applied Science Degree. This certificate is being suspended, but a revamped certificate will be brought forward for the board to approve at the February board meeting.

College Policies—Board of Education Series: Policy #1510—Auditor for Chemeketa Community College Board of Education, Policy #1530—Budget Officer, and Policy #1540—Custodian of Funds

Alice Sprague said the Board Policy Committee met, reviewed these three policies, and discussed needed changes to the policies. These policies will be brought forward to the board for approval at the February board meeting.

Oregon School Boards Association (OSBA)

Diane Watson stated that Chemeketa pays membership dues to OSBA, entitling the college to vote in OSBA's elections for the Marion County regional positions on the OSBA Board of Directors. During the 2025 elections for Marion County Board Position 11, no candidate received a majority of the votes cast, requiring a second regional ballot between the two candidates with the highest number of votes. The Chemeketa Board of Education may choose to take action to support a candidate in the runoff election and the voting period ends on January 22nd. Board members discussed the topic and stated they have not taken a position on OSBA elections in the past.

Ken Hector moved and Neva Hutchinson seconded a motion stating that the Chemeketa Board of Education does not participate in the candidate vote for OSBA Marion County board positions.

I. STANDARD REPORTS

Personnel Report

Courtney Saldivar, Associate Vice President, Human Resources said the report stands as written.

Budget Status Report

Aaron Hunter noted on the Statement of Resources and Expenditures that the year-end audit is complete and there is now a beginning fund balance number, and the property taxes and tuition fees are trending as usual. The state appropriation fourth payment will be received in January. This year there are five payments. On the Budget Status report everything is trending as usual. On the Quarterly Update of Other Funds, the funds on the upper section are down approximately \$2 million in overall balance, and self-support is down approximately \$1.5 million due to the timing of when funds are expected. In the lower section, compared to last year the capital project numbers for obligation are higher and that is due to some of the bond projects being worked on. On the Status of Investments report, the short-term fund rate continues to go down. Investments are down about 12.5 percent compared to last year due to retro payments made earlier this fall.

Capital Projects Report

Aaron Hunter provided updates on the ongoing projects and noted that most of the projects are bond projects. The Building 2 restoration project is completed and the new kitchen is now open for service.

Institutional Advancement Foundation Quarterly Report

Marie Hulett, Associate Vice President/Executive Director, Institutional Advancement, said the report stands as written and thanked those who donated to the auto program. The scholarship application window is open from February 1 through April 15.

Grant Activities October–December 2025

Gaelen McCallister, Director, Institutional Grant Development, said the report stands as written and discussed the Veterans grant and STEM grant that the college received.

Fall Term 2025 Enrollment Report

Colton Christian, Dean, Academic and Organizational Effectiveness, discussed key takeaways. Fall term 2025 had higher full-time equivalency (FTE) from a year ago; total FTE and reimbursable FTE increased by six percent; and headcount has increased four percent compared to last year. Winter term enrollment is up just under one percent.

Post Completion Outcomes Report

Colton Christian discussed key takeaways. The employment rate for Chemeketa graduates is slightly lower than the college's peers at the one-year mark, but is higher at five and ten years after graduation. Graduate earnings are lower than the college's peers at one year, but the gap narrows or reverses by ten years after graduation. The percentage of Chemeketa's graduates employed in Oregon is higher than the college's peers at one year and the gap widens over time.

PAST EVENTS

Karaoke

- On Tuesday, January 13th, 106 students enjoyed snacks and sang their favorite songs at Karaoke. Our goal was to provide an outlet for students to unwind, have fun, and meet new people on campus.

Evening Resource Fair

- On Tuesday, January 20th, 145 students had the opportunity to get info about campus resources. ASC's goal was to help students who are on campus later in the day, or who have classes during our typical event hours to get info about resources, enjoy pizza, and connect with the campus community.

Ice Skating Field Trip

- On Friday, January 23rd, we took a group of 25 students on a field trip to the Lloyd center to ice skate and get lunch afterwards. The goal with this event was to encourage students to make social connections and allow them to destress as the term ramps up.

Tuition forum

- On Tuesday, January 27th, 12 students attended the tuition forum to hear from Aaron Hunter and Ryan West about the proposed updates to tuition and fees. Students had the chance to ask questions and give feedback.

Civic Engagement Workshop

- On Wednesday, January 28th, ASC hosted a civic engagement workshop in the Student Center led by Oregon Community Table on Postsecondary Education and Training (OCTPET), a statewide community advocacy group focused on addressing the disparities impacting underrepresented students in postsecondary education. Chemeketa Community College Board of Education Elections

The term of office of each Chemeketa Community College Board of Education member shall be four (4) years, commencing on July 1 following the election. The term of a College Board of Education member expires June 30 following the regular district election at which a successor is elected. Elections shall be held every two (2) years, in odd-numbered years. Terms of College Board of Education members are staggered so that, as nearly as practical, one-half of the College Board of Education members shall be elected at each election.

In any election in which a person receiving a sufficient number of votes for election is not qualified, the person receiving the next largest number of votes who is qualified to be a member shall be declared elected.

Vacancies on the Chemeketa Community College Board of Education

The Chemeketa Community College Board of Education shall declare the office of a college board member vacant if it finds any of the following:

- a. The incumbent has died or resigned.
- b. The incumbent has been removed or recalled from office or the election of the incumbent thereto has been declared void by the judgment of a court.
- c. The incumbent has ceased to be a resident of the district and zone from which the incumbent was nominated or elected.
- d. The incumbent has ceased to discharge the duties of office for two consecutive months unless prevented therefrom by sickness or other unavoidable cause or unless excused by the chairperson of the College Board of Education.

When a vacancy is declared the remaining College Board of Education members shall meet and appoint a person to fill the vacancy from any of the electors of the district zone from which the vacancy occurs.

The period of service of a College Board of Education member appointed to a vacant position commences upon appointment and expires June 30 following the next regular district election at which a successor is elected. The successor shall be elected to serve the remainder, if any, of the term for which the appointment was made. If the term for which the appointment was made expires June 30 after the election of the successor, the successor shall be elected to a full term. In either case, the successor shall take office on July 1.

The president/chief executive officer shall establish administrative procedures to solicit applications that assure ample publicity to and information for prospective candidates. The College Board of Education will determine the schedule and appointment process.

Public Participation at Chemeketa Community College Board of Education Meetings

There will be a time at each regularly scheduled Chemeketa Community College Board of Education meeting for the general public to address the College Board of Education regarding items not on the agenda, as well as not on the agenda.

When the public comment portion of the College Board of Education meeting is opened, the presiding officer will read the college guidelines for public comment (time, limit, etc.).

Members of the public also may submit written communications to the College Board of Education on items on the agenda or speak to agenda items at the College Board of Education meeting. Written communication regarding items on the College Board of Education's agenda should reach the office of the president/chief executive officer no later than five (5) working days 24 hours prior to the meeting at which the matter concerned is to be before the College Board of Education. All such written communications shall be dated and signed by the author and shall contain the residence or business address of the author and the author's organizational affiliation, if any.

Members of the public also may submit written communications to the College Board of Education on items, not on the agenda or speak to items not on the agenda at the College Board of Education meeting.

All written communications to the College Board of Education will be reviewed and handled appropriately.

Claims for damages are not considered communications to the College Board of Education under this rule but shall be submitted to Chemeketa's general counsel.

Chemeketa Community College Board of Education Meeting Speakers and Public Comments

Persons may speak to the Chemeketa Community College Board of Education either on an agenda item or on other matters of interest to the public that are within the subject matter jurisdiction of the College Board of Education.

Oral presentations relating to a matter on the agenda, including those on the consent agenda, shall be heard before a vote is called on the item.

Persons wishing to speak to matters, not on the agenda shall do so at the time designated at the meeting for public comment.

Those wishing to speak to the College Board of Education are subject to the following:

1. The chairperson of the College Board of Education may rule members of the public out of order if their remarks do not pertain to matters that are within the subject matter jurisdiction of the College Board of Education or if their remarks are unduly repetitive.
2. Non-scheduled substitutes may not speak in place of scheduled speakers unless alternates have been submitted on the original request.
3. Speakers shall sign a request to address the College Board of Education at the beginning of the meeting at which they wish to speak.
4. The request shall include the person's name and name of the organization or group represented, if any, and a statement noting the agenda item or topic to be addressed.
5. No member of the public may speak without being recognized by the Chairperson of the College Board of Education.
6. Each speaker will be allowed a maximum of three (3) minutes per topic. Thirty (30) minutes shall be the maximum time allotted for public speakers on any one subject regardless of the number of speakers at any one College Board of Education meeting. At the discretion of a majority of the College Board of Education, these time limits may be extended, or reduced.
7. Each speaker coming before the College Board of Education is limited to one presentation per specific agenda item before the College Board of Education, and to one presentation per meeting on non-agenda matters.

Chemeketa Community College Board of Education members and employees shall adhere to state laws relating to financial conflict of interest and government ethics. The College Board of Education maintains high standards of ethical conduct for its members. Members of the College Board of Education are responsible to:

- Act only in the best interests of the entire community.
- Ensure public input into college board deliberations; adhering to the law and spirit of the open meeting laws and regulations.
- Prevent conflicts of interest and the perception of conflicts of interest.
- Exercise authority only as a College Board.
- Use appropriate channels of communication.
- Respect others; acting with civility.
- Be informed about the college(s) educational issues, and responsibilities of College Board membership.
- Devote adequate time to college board work, including preparing for college board deliberations by reviewing the agenda and materials prior to meetings.
- Maintain confidentiality of executive sessions.

All College Board of Education members are expected to maintain the highest standards of conduct and ethical behavior and to adhere to the College Board's Code of Ethics. The College Board of Education will be prepared to investigate the factual basis behind any charge or complaint of college board member misconduct. A College Board of Education member may be subject to a resolution of censure by the College Board of Education should it be determined that trustee misconduct has occurred. Censure is an official expression of disapproval passed by the College Board of Education.

A complaint of College Board of Education member misconduct will be referred to an ad hoc committee composed of three College Board of Education members not subject to the complaint. In a manner deemed appropriate by the committee, a fact finding process shall be initiated and completed within a reasonable period of time to determine the validity of the complaint. The committee shall be guided in its inquiry by the standards set forth in the College Board of Education's Code of Ethics as defined in policy. The College Board of Education member subject to the charge of misconduct shall not be precluded from presenting information to the committee.

The committee shall, within a reasonable period of time, make a report of its findings to the College Board of Education for action.

Chemekesta Community College Personal Use of Public Resources – Board of Education

The Chemekesta Community College Board of Education members of the college, as public officials, may not use or attempt to use official position or office to obtain financial gain or avoidance of financial detriment for the public official, a relative or member of the household of the public official, or any business with which the public official or a relative or member of the household of the public official is associated, if the financial gain or avoidance of financial detriment would not otherwise be available but for the public official's holding of the official position or office.

This prohibition does not apply to:

- a. Any part of an official compensation package as determined by the public body that the public official serves.
- b. The receipt by a public official or a relative or member of the household of the public official of an honorarium or any other item allowed under ORS 244.042.
- c. Reimbursement of expenses.
- d. An unsolicited award for professional achievement.
- e. Gifts that do not exceed the limits specified in ORS 244.025 received by a public official or a relative or member of the household of the public official from a source that could reasonably be known to have a legislative or administrative interest.
- f. Gifts received by a public official or a relative or member of the household of the public official from a source that could not reasonably be known to have a legislative or administrative interest.
- g. The receipt by a public official or a relative or member of the household of the public official of any item, regardless of value, that is expressly excluded from the definition of "gift" in ORS 244.020.
- h. Contributions made to a legal expense trust fund established under ORS 244.209 for the benefit of the public official.

Chemeketa Community College has adopted a seven-year strategic planning cycle aligned with its institutional cycle of accreditation. The current cycle began in the 2022-23 academic year and runs through 2028-29. This Strategic Plan is intended to act as a map to guide the college to mission fulfillment at the culmination of the cycle. In alignment with participatory governance principles, the College Council, a representative group of employees and students, is responsible for the development and oversight of strategic planning.

The Strategic Plan is organized into five Strategic Themes, which represent key components of the college mission and vision. Each Strategic Theme is further broken down into Indicators which clarify and define the theme.

A companion to the Strategic Plan, the Scorecard contains specific metrics — organized by strategic theme and indicator — that will be used to define progress toward mission fulfillment. Each year, the Strategic Plan and Scorecard is updated with specific actions planned to impact the metrics associated with a particular indicator. At the end of the year, progress toward these actions is documented.

As a Hispanic Serving Institution (HSI), Chemeketa is dedicated to authentically serving Latino/a/x and minoritized students and the community. To monitor fulfillment of this commitment, the college has developed a Disaggregated Scorecard containing many of the metrics from the Strategic Plan and Scorecard in a disaggregated format. 



BOND PROJECTS

Community Fields/Courts Upgrades

This project encompasses the renovation of the baseball and softball fields, incorporating artificial turf surfaces and updated lighting systems. These enhancements are designed to improve drainage and broaden the availability of the facilities for both Chemeketa and community teams, allowing for utilization during adverse weather conditions and extending the operational hours past sunset.

Update: All infrastructure work has been completed. Concrete pads to support the bleachers and light poles are currently underway. The baseball and softball field will be completed early in April and the soccer field construction will begin shortly thereafter.

Building 7 Renovation

The goal of this project is to realize the full potential of the existing facility to promote and support the physical and wellness-related educational offerings and activities, and to revitalize and preserve an aging and outdated asset that has tremendous potential to serve the needs of the college community. In realizing these initial goals, we send a message to our community that vitality and wellness are important aspects of both academic and lifetime achievement.

Update: Value engineering exercises conducted with the Construction Manager/General Contractor (CM/GC) and the architectural team have resulted in cost reductions that align with the established budget while preserving the core project objectives. While most priority objectives have been retained, lower-priority elements will be completed with minimal alterations to the physical layout but will feature updated finishes. Any additional savings realized during the final design and bidding process will be allocated to reinstate features in the lower-priority areas that were previously removed to meet budgetary constraints. Construction is anticipated to commence in the Spring of 2026.

Trades Center

This project will provide flexible lab and shop space to expand hands-on training in high-demand trades such as welding, ironworking, and carpentry. It will help to strengthen partnerships with industry, support apprenticeships and workforce training, and prepare students for family-wage careers that meet the region's economic needs.

Update: The project architect has been selected and is developing a preliminary schedule. The internal project team and the architect will soon begin programming (pre-design). This crucial preliminary step involves defining project objectives, specific needs, and scope before design

drawings start. Programming focuses on research, budget, quantitative space needs, and desired experience, resulting in a comprehensive project brief that guides the entire building process.

Blue Parking Lot

The Blue Parking Lot is slated for a complete overhaul due to its deteriorated condition, primarily stemming from insufficient subgrade support beneath the asphalt. This critical project aims to not only replace the failing infrastructure but also to implement a modernized layout that prioritizes pedestrian and vehicular safety. Furthermore, the redesign will incorporate modern stormwater treatment solutions, bringing the lot into compliance with current regulations and best practices.

Update: The parking lot layout is currently being finalized. Consultation is underway with programs directly adjacent to the lot to obtain input to ensure their needs are met by the final design. The owner's representative is also proactively engaging with programs whose access will be affected during construction to develop alternative solutions. Completion of the parking lot construction is anticipated during the summer of 2026.

Security and Lighting

To enhance safety for staff, faculty, and students, improvements are underway to replace aging security camera equipment. This initiative involves moving to a single, unified system, developed in collaboration with the Public Safety Department, for ease of use and increased capabilities. Additionally, we are upgrading exterior and interior lighting which will improve learning spaces and further contribute to a safer environment. These improvements are inclusive of all Chemeketa locations.

OTHER PROJECTS

Building 2 Ice Storm Restoration

The building 2 restoration project has been successfully completed, and the new kitchen is open for service.

The Chemeketa Cooperative Regional Library Service (CCRLS) report addresses activities in four areas: CCRLS Advisory Council; Polk, Yamhill and Marion Library Association (PYM); administration and automation; and statistics.

CCRLS ADVISORY COUNCIL

September -January meetings included: discussion/approval of changes to the net lending reimbursement and a new policy supporting those changes; current library membership application process and policy implications; basic vs. full patron service levels; FY 2026-2027 CCRLS budget.

PYM

September -January meetings included: discussion/approval of changes to the net lending reimbursement and a new policy supporting those changes; current library membership application process and policy implications; basic vs. full patron service levels; replacement of the current 'bridge' system; prospect of changing marketing platforms; anticipated shortfall for funding Kanopy service; FY 2026-2027 CCRLS budget.

CCRLS ADMINISTRATION AND AUTOMATION

The FY 2026-2027 CCRLS budget proposal was approved by PYM Directors & CCRLS Advisory Council. It will be repackaged and presented to the College Board as part of its annual budget approval process.

A comprehensive review and documentation of all CCRLS policies continues. Per the Sep 2025 Board report, the 'net lending' reimbursement has been reconceived as a 'collection support' reimbursement, which will be implemented in FY 2026-2027. A policy supporting this change is now in place (REIMB-002). Remaining reimbursement-related policies, eCommerce distribution & mileage reimbursement, are now in draft and will be presented to stakeholder groups soon.

The 'bridge' system which facilitates discovery & requesting between public member libraries and the college library is end-of-life as of 6/30/2026. *Tipasa* will replace the current platform. There will be no significant increase in annual expenditure. Implementation activities may begin in Spring 2026.

Delivery of a new mobile app is still pending. Deployment of the new app is paused until a 'linked accounts' feature is available. This feature is in active development by SirsiDynix.

A Windows 11 upgrade is almost complete. This effort began in Fall 2025 and encompasses all workstations on the CCRLS network.

Its focus is to serve faculty and students at community colleges and broad access institutions country wide. Learnvia was publicly announced on January 29, 2026, and our press release introduced the pilot. Faculty and students who are willing to test, reflect, and share their perspectives are required for a meaningful process in learning.

Each year Chemeketa reviews student tuition and fees as part of the budget development process. The recommendation is brought to the Board for discussion in January. The college's values of adaptability, belonging, community, opportunity, and quality continue to focus the institution in supporting initiatives, strategies, programs, and operations that will allow it to meet its goals related to student success. Chemeketa's mission is to transform lives and strengthen communities through quality education, services, and workforce training.

Tuition and Fee-Setting Guidelines

- Balance the need for revenue to maintain levels of service with affordability for students
- Consider the level of state funding along with anticipated tuition and fee revenues when recommending changes to the tuition and fee rates
- Incorporate annual inflationary increases to maintain equity among cohorts and avoid the eventual necessity of large rate increases to re-align with college guidelines
- Maintain an alignment with Chemeketa's comparator colleges, identified as: Clackamas Community College, Lane Community College, Linn-Benton Community College, Mt. Hood Community College, and Portland Community College
- Recognize that there is currently no state funding available to supplement the tuition and fee funding for the college's Bachelor of Applied Science and Bachelor of Science in Nursing degree programs





The Pharmacy Technician Associate of Applied Science (AAS) degree was established to provide students with an extended academic pathway beyond the certificate level. The degree was designed to offer deeper academic preparation, support career advancement, and serve as a potential stepping stone for students interested in pursuing further education in healthcare. Despite these intentions, the program has consistently struggled with low enrollment and limited student interest over the past several academic years as most students enrolled in the Pharmacy Technology program have opted to pursue the shorter certificate track, which provides direct employment opportunities.

Chemeketa's Pharmacy Technology Advisory Committee, composed of pharmacy leaders, and several Pharmacy Technician members who themselves completed the AAS degree, agreed that the degree does not align with current industry expectations. Employers continue to prioritize certification, ASHP-accredited training, and experiential readiness over associate-level degrees.

The program is requesting permission to suspend the Pharmacy Technician AAS degree effective spring 2026 as there are no current students enrolled in the program.

It is recommended that the College Board of Education approve the suspension of the Pharmacy Technician AAS degree.

As part of Chemeketa's commitment to academic quality, workforce responsiveness, and equitable student success, the Pharmacy Technician certificate of completion has undertaken redesign of the curriculum to align with the American Society of Health-System Pharmacists (ASHP)/Accreditation Council for Pharmacy Education (ACPE) accreditation standards.

Suspension of the existing Pharmacy Technician certificate of completion, effective end of Spring 2026 and the implementation of a new Pharmacy Technician certificate of completion in Fall 2026, will ensure that graduates are eligible for national certification and prepared to work in contemporary pharmacy environments, including retail, hospital, and compounding settings.

It is recommended that the College Board of Education approve both the suspension of the current Pharmacy Technician certificate of completion and the new Pharmacy Technician certificate of completion.

This policy was last reviewed by the board in December 2022. There are no edits recommended for this policy.

BUDGET OFFICER—POLICY #1530

This policy was last reviewed by the board in December 2022. It is recommended to add “in accordance with local budget law” language to policy #1530. As a public entity, Chemeketa must follow specific state-mandated guidelines for management of state funds and ensuring accountability for college operations.

CUSTODIAN OF FUNDS—POLICY #1540

This policy was last reviewed by the board in December 2022. It is recommended to add the word “regularly” to indicate how often the custodian of funds should report the status of college funds to the Board of Education.

For the above-noted policies, new language is underlined and any former language has been stricken with lines through the text.

It is recommended that the College Board of Education approve the proposed changes to college policies #1510—Auditor for the Chemeketa Community College Board of Education, #1530—Budget Officer, and #1540—Custodian of Funds.

College Board of Education Series (1000)

#1510

Auditor for the Chemeketa Community College Board of Education

The Chemeketa Community College Board of Education shall appoint an independent auditor to conduct an examination of the college district's financial affairs. The auditor appointed must be on the roster of accountants authorized by the Oregon State Board of Accountancy to conduct municipal audits and must otherwise qualify according to criteria which may be established by the board.¹

Function of the Auditor

The auditor shall determine whether the statement of financial position and statement of revenue for the college district's funds, together with supporting schedules, fairly present the results and transactions for the fiscal year under review in accordance with generally accepted municipal accounting principles and requirements by the Secretary of State, tried on a basis consistent with the prior year.

The Auditor's Examination

The auditor's examination shall be:
Of the statement of financial condition and related statement of revenue and expenditures for each fund of the district at the end of each fiscal year.

Conducted in accordance with generally accepted auditing standards as promulgated by the American Institute of Certified Public Accountants and with the minimum standards of audit reports, certificates, and procedures for Oregon municipal corporations as prescribed by the Secretary of State.

Auditor Recommendations

Following discussion with the college president/chief executive officer and appropriate employees, the auditor may also provide as an additional product of their examinations a management letter to the College Board of Education setting forth significant recommendations concerning the financial and accounting practices or procedures which should be brought to the College Board of Education's attention.

The custodian of funds shall report regularly to the College Board of Education the status of all college funds and the investments thereof.¹



